#### IJA Video Copyright by Don Lewis

The IJA has a rich vault of video from years gone by. There has been an interesting dialog recently on the forum about how we should protect our rights to this footage, and how to take advantage of it. The IJA festival registration includes a video consent, which basically gives the IJA the right to video images of the festival. Members are allowed to use their own cameras at the festival, with the permission of the person being filmed. Many people ask workshop leaders if they can tape, and are generally given permission. The stage shows and competitions, however, are the unique province of the IJA to utilize.

Rarely, some person will extract a scene from one of our videos and place it on a public website such as YouTube. That is a violation of our rights. The corrective process has several steps. Initially, we request that the offending footage be voluntarily removed. In some cases, we may choose to allow the use if the IJA is being promoted. The next step is to file a DMCA request with the ISP or website owner asserting that we do own the copyright. Typically the file is removed or quarantined for a period while the user is given the chance to file an objection. If no objection is filed then the material simply remains offline. If there is an objection, then things get interesting. ISPs and websites are not in the adjudication business, so they expect people to come back to them with a properly adjudicated proof of ownership.

That is essentially a legal process, with all the assorted legal costs that that might entail. The general tenor of the forum discussion was that the IJA should not invest a lot of money defending copyright of old videos. If the legal minds out there are aware of options beyond what I have described, please let me know what they are.

One member made the interesting proposal that the IJA should release the competition videos from years past into the public domain, possibly under a creative commons license. Some objection was raised to this concept because the IJA basically loses control of derivative works. This may not be a major issue as long as the IJA gets positive promotion from such efforts. Another alternative is to embed video segments in a frame that contains the IJA's web address, and then publish prior year competition routines on the IJA website. At least if someone misappropriated one of those video images, it would come complete with our brand embedded in the image. Note that the IJA's records are quite thin even in the recent past, so in many cases the music would have to be removed from routines before placing them on the IJA website.
